

Release/Waiver of Liability

This Is a Contract

Activity Organizer: THE ART ROOM LLC (Organizer)

Activity Description: ART CLASSES (ADD ADDITIONAL) ("Activities")

In consideration of being allowed to participate in the Activities, IF I OR THE PERSON FOR WHOM I AM SIGNING THIS CONTRACT IS INJURED participating in the Activities or while present on the Organizer property, I AGREE TO BE LEGALLY BOUND by the promises set forth below. I understand that the term "Organizer" includes the Organizer identified above, its members, officers, directors, agents, servants, and employees and, if not owned by the Organizer, the owners of the land on which the Activity is taking place (that land, the "Property").

I WILL NOT SUE the Organizer and I FOREVER RELEASE, SAVE, INDEMNIFY AND HOLD HARMLESS the Organizer from any and all liability from any injury,(including exposure to COVID-19 and or any other virus) loss, liability, damage, or cost of any kind that may occur as a result of any injury.

I AGREE THAT THE ABOVE PROMISES ARE LEGALLY BINDING even if I contend that my injuries are wholly or partly the result of NEGLIGENCE or other CONDUCT on the part of Organizer for which a release is not contrary to public policy.

I understand that the Activities may be INHERENTLY DANGEROUS.

I voluntarily ASSUME THE RISK OF INJURY OR EVEN DEATH while participating in the Activities or entering the Property. If I am injured, I authorize Organizer to provide EMERGENCY FIRST AID and any medical or first aid personnel to provide MEDICAL CARE until such time as I or someone authorized by my medical care power of attorney or otherwise by law is able to act on my behalf and I FOREVER RELEASE, SAVE, INDEMNIFY AND HOLD HARMLESS the Organizer from any and all liability from any injury,(including exposure to COVID-19 and or any other virus) caused by such action.

I recognize my responsibility to INSPECT the facilities within the Property, to exercise GOOD JUDGMENT, to ACT RESPONSIBLY, and to OBEY all of Organizer's oral or written guidance, instructions (including signage), and warnings.

I AGREE that the promises set forth above also apply to any LOSS OF OR DAMAGE to any of my belongings for which Organizer may be legally liable in connection with the Activities including any transportation or storage.

I release to Organizer and authorize Organizer to produce, reproduce, broadcast, and otherwise use PHOTOS, VIDEOS, and other depictions, likeness , or images of me, in any media form in connection with my attendance at or participation in the Activity, without compensation, for unlimited duration.

I am 18 YEARS OF AGE OR MORE or I am SIGNING AS PARENT OR GUARDIAN of a minor child with the consent of the other parent or guardian (if any). I understand that I may be giving up the rights of my child and spouse to sue as well as giving up my own right to sue. I have read and understood these promises and am VOLUNTARILY signing below INTENDING TO BE LEGALLY BOUND.
